This is a **one day festival**: Saturday, May 7, 2011. The festival is produced by Claremore Main Street, Inc., a non-profit 501(c)3 organization, the Claremore Chamber of Commerce and the Claremore CVB.

- **HOURS AND LOCATION:** Festival hours are 10:00am—6:00pm. The **OUTDOOR** festival will be held in three consecutive blocks of downtown Claremore.
- **BOOTHS:** The basic vendor space fee is \$50.00 if received **prior to Friday, April 29, 2011**. Space fee after that date will be \$75.00

All spaces are 10' X 10'. If you require electrical service, it can be provided for an additional \$10.00. You need to bring your own tables, chairs, canopy, power strip (for additional plug-ins), tape and extension cords.

- **TIMES:** Check in time begins at 7:30 a.m. All booths must be ready by 9:45 a.m. All vehicles must be removed from the festival area by 9:30 a.m. This will be strictly enforced. Vehicle re-entry is prohibited until closing at 6:00 p.m. Early set-up will not be available.

Any booth not occupied by 9:00 a.m. will be automatically released to another exhibitor with **NO REFUND** to original entrant. Early departure is not acceptable and may forfeit your reservation for future shows.

- **PUBLICITY:** Will be provided through local and statewide media advertising including newsprint, television, radio, banners and flyers.
- **SALES TAX:** By law, all exhibitors must collect 9% sales tax on all sales. Information will be provided for remittance of tax collected in your registration packet. The Oklahoma Tax Commission will be provided a vendor list.
